Regular Membership (all membership privileges)

Single Membership: \$440.00 per year, \$110 payable quarterly (Jan, Apr, Jul, Oct)

Family Memberships: \$632.00 per year, \$158.00 payable quarterly (Jan, Apr, Jul, Oct)

College Student Membership (May-August): \$125 (\$50 of which will be applied to equipment if student later decides to become regular member).

Substitute Membership (limited membership privileges): \$40.00 per quarter

- New members will be assessed annual dues based on their starting month and are assessed a one-time \$100 equipment fee at the time of joining the club.
- Membership dues are invoiced quarterly on Jan 1, Apr 1, Jul 1, Oct 1 with payment due by the end of the month. If you have not made your payments or other arrangements with the treasurer by the due date, you will not be allowed to row or represent ORC at regattas.
- A signed ORC waiver form must accompany this membership for each individual who plans on rowing.
